

**WAIVER AND RELEASE OF ALL CLAIMS AND ASSUMPTION OF RISK**

**Event: Arizona Ride of Honor Bicycling Activities**

**Please Read Carefully**

In exchange for me (or my child) being allowed to participate in the above-listed event, I agree to waive, release and forever discharge any and all claims, rights and causes of action against NOT ONE MORE, RED MOUNTAIN BRUMBYS, and the CITY OF MESA, an Arizona municipal corporation, and all of these entities' respective officers, officials, employees, agents and volunteers (collectively the "Event Organizers"), for injury or damage caused or alleged to be caused in whole or in part by the negligence of the Event Organizers. I agree to this waiver and release for myself (or on behalf of my child) and for all our heirs, personal representatives, next of kin, and assigns. I understand that this means that I will not make such claims against or sue the Event Organizers for injuries or damage sustained by me or my child.

My waiver and release includes, but is not limited to, the Event Organizer's negligence in: rescue operations, adequacy of facilities and provisions, site preparation, training and instructions to event personnel, interpretation and enforcement of rules, provisions of medical or emergency medical assistance, supervision of and safety for the participants.

I understand and voluntarily assume all risks associated with my (or my child's) participation in this event. The event will be conducted over public roads that will remain open for vehicular traffic during the event. I recognize that injuries and damage may be caused by any of the following: vehicular traffic and the terrain; lack of facilities or hydration; temperature and weather; falling, tripping or being struck by another individual or vehicle; exposure to bodily fluids, infection, or disease; bodily reactions to food or materials used in the event; equipment used in the event; a condition of the land or building where the event is located; criminal acts of individuals at the event; an error in administering first aid; and other similar acts, incidents, or conditions. The type of injuries may range from minor injuries and fractures to paralysis, brain damage, and death.

I am (or my child is) physically capable of participating in this event. I have (or my child has) the necessary degree of skill, training, experience and ability to participate in the event. I do not expect the Event Organizers to supervise, instruct, or train me (or my child). I further agree that if at any time I believe conditions to be unsafe, I will immediately discontinue my (or my child's) further participation in the event.

This waiver and release of all claims and assumption of risk is intended to be as broad and inclusive as permitted by the laws of Arizona. If any portion of this document is held invalid, the remainder shall continue in full force and effect.

I understand that at this event and related activities, I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the Event Organizers.
